UMB received a STARS Silver rating from the Association for the Advancement of Sustainability in Higher Education

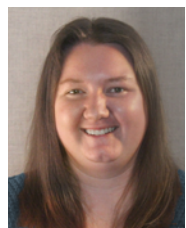
